Dear Mayor and Councilors,

I'm writing to request that you officially designate October 2025 as National Disability Employment Awareness Month (NDEAM). A mayoral proclamation will also strengthen the support shown by the Municipality of Northern Bruce Peninsula through participation in Light It Up! For NDEAM on October 16th, 2025.

NDEAM activities acknowledge and celebrate the workplace contributions of people who have a disability, and business successes and benefits stemming from hiring with a focus on inclusion.

October is a good time to recognize the need for ongoing efforts and to raise awareness that all businesses must review their recruitment processes. Disability inclusion isn't just about compliance with AODA standards, human rights laws, or corporate social responsibility; it's strategically important. Research shows that disability-inclusive hiring can boost growth, innovation, and profitability for local businesses.

Nearly 645,000 Canadians with disabilities want to work but are under-employed. The 2022 Statistics Canada survey shows their employment rate is 62%, versus 78% for those without disabilities. About 71% of small businesses haven't hired disabled staff, often due to lack of awareness of their skills. Although employment is rising, barriers like negative attitudes remain a major challenge for equitable employment.

I thank you for considering this request. The combination of participation in *Light It Up! For NDEAM*, a mayoral proclamation of National Disability Employment Awareness Month would send a powerful message to shine a spotlight on disability-inclusive hiring.
